In terms of Section 74 of the Local Government Municipal Systems Act, act No. 32 of 2000 read together with the Indigent Policy of Umvoti Municipality notice is hereby given in that Umvoti Municipality calls for residents, who qualify, to register as Indigent for the 2018/2019 Financial Year.

Umasipala waseMvoti ngokugunyazwa isigaba 74 soMthetho olawula ukuphathwa kukaMasipala ongunombolo 32 wonyaka ka 2000, ufundwa kanye nenqubomgomo ehlongozwayo yezaphulelo kaMasipala wase Mvoti, umema zonke izakhamuzi ezilungele ukuthola izaphulelo ukuba zibhalisele izaphulelo zonyaka mali ka 2018/2019.

INDIGENT APPLICATION

Residents must meet the following criteria in order to apply for Indigent Support:

1. There must be a combined household income of twice the Government Social Pension.
2. **Applicant must be a member of a domestic household who is responsible for the payment of the services and is receiving services from Umvoti Municipality**
3. Must not own more than one (1) property
4. The applicant must reside permanently on property

3. Umfaki wesicelo kumele engabi nayo indlu engaphezulu kweyodwa
4. Umfaki wesicelo kufanele ehlale ngokugcwele kuleso sakhiwo.

The Department of Cooperative Governance & Traditional Affairs, who provides continuous support through the Indigent process has now been tasked to develop a Standard National Indigent Register, for this process to be successful they require that all Indigent applicants to provide written consent to SARS to disclose taxpayer information to the Municipality as well as National COGTA for purposes of only verifying the details of income levels disclosed to the Municipality in support of the application for Indigent subsidy.

In light of the above, the consent form will be attached to the Umvoti Municipality Indigent application form for the 18/19 Financial Year, your cooperation will be most appreciated.
